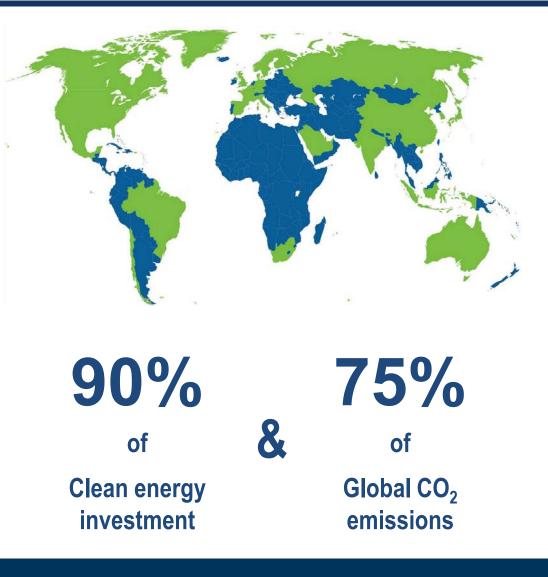
Clean Energy Ministerial

Solutions Center: Background & Vision

- Multilateral initiative, of the Clean Energy Ministerial, is co-led by the Australian Department of the Environment and Energy, Sweden's Ministry of the Environment and Energy, and the U.S. Department of Energy.

She works on clean energy policies and provides solar technical assistance to local, state, and national-level policymakers. She leads the implementation of the USAID Distributed PV Toolkit. She holds a Masters of Public Affairs (M.P.A) with a concentration on energy and climate change policy from Indiana University and a B.A. in Government from Claremont McKenna College.



Sherry Stout, Engineer, National Renewable Energy Lab



Sherry is an engineer at the U.S. Department of Energy's National Renewable Energy Laboratory (NREL). Much of Sherry's work involves energy resilience planning at multiple jurisdictional levels. Sherry is currently working the U.S. federal government agencies, American Indian Tribes, and national governments in South America, South East Asia, and North Africa to plan and implement resilient energy programs. Her specific resilience research areas include grid integration of distributed renewable generation, energy/water nexus issues, and rural electrification.



Jason Coughlin, Senior Researcher, National Renewable Energy Lab



Mr. Coughlin focuses on solar project financing as well as on the non-hardware costs (e.g. permitting, inspection and interconnection) associated with distributed PV. Currently, Mr. Coughlin manages NREL's participation in the SolSmart program, a DOE-funded effort focused on assisting local governments reduce solar soft costs. In addition, Mr. Coughlin is currently engaged in topics such as community solar, increasing access to solar for lower income households, solar on tribal lands and distributed solar in Latin America. Previous careers include banking, rural housing development in Latin America and the Peace Corps. Mr. Coughlin holds a Master of International Business Studies with concentrations in Finance and Portuguese from the University of South Carolina, as well as a Certificate of Advanced Study in Environmental Policy from the University College at the University of Denver.
